II. Adoption of the Agenda

There was a suggestion to move "Proposals" before "New Business" so that Professor Drake would not need to stay for the entire meeting. Motion to approve with amendments: Baciuna, Second: Shedd: Unanimous approval.

III. Approval of Minutes from April 19, 2018 and Minutes by Email

IV. Old Business

V. Proposals

a. Co-requisite Math Curriculum Summer 2018 (Sean Drake) This proposal is to request funding for 8 faculty to work with each other and faculty from sister colleges to create co-requisite courses for Math 11, 12 and 25 in order to maximize the probability of students successfully completing a college level math course in one year. Math 35, 36, 10 and 1A are other possible courses for focus. The Committee recommended that Mr. Drake update the proposal to include specifics about the urgency of the work.

Motion to approve: Escobar, Second: Shedd: Unanimous approval. Total approved: \$12,420.

VI. New Business

- a. Information Items
 - i. The Co-requisite Coordinator Special Projects are ending this month and will be shifted to BSSOT moving forward.
 - ii. The Governor's revised budget proposes integration of the Student Success and Support Program, Student Equity Program, and the Student Success for Basic Skills Program into a block grant program. As Kathryn learns more, she will report back to the Committee.
 - b. June 8th Professional Development: AB 705 and Student Success
 - i. Kathryn Stevenson reminded the Committee about this upcoming event.
 - c. AB 705 and ESL at MVC Joyce Kim
 - i. Joyce Kim shared the most recent updates to the RCCD ESL Position Statement on AB 705. This was put together in collaboration with District-wide ESL colleagues



and addresses the new AB 705 implementation timeline. Dr. Kim plans to seek guidance regarding data collection and statistical analysis.

AB 705 FAQs

i. Kathryn Stevenson shared the AB 705 Implementation FAQs with a few highlighted areas. There are some concerns from faculty of possibly discouraging students due to the reduction of pre-transfer courses.

e. BSI SMART Goals

i. Kathryn Stevenson shared two options for making BSI goals SMART goals. She recommended Option A: "Smart goals – without baseline and percentage decrease/increase." Time in remediation will be decreased using multiple measures, reducing developmental educational pipelines, decreasing the number of non-accelerated remedial courses, and increasing offerings in accelerated courses. There will be an increase in students that successfully complete degree-applicable or transfer courses within the first 3 terms or years of enrollment by increasing Supplemental Instruction and tutoring, and increasing instructional supports and educational partnerships aimed at improving instruction.
